

SOMEC: STEFANO ROSA ULIANA APPOINTED TO LEAD MESTIERI

Before that, he spent about ten years at Electrolux, where he held progressively responsible roles in both Italy and Sweden. In addition to nearly twenty years of international experience, eight of which were in the United States, Uliana has worked for multinational companies, family-owned businesses, and private equity-controlled firms, managing development projects and overseeing various M&A transactions.

Mestieri is composed of various Italian companies specializing in the high-quality artisanal processing of different materials, including metals, marble, and wood. These companies contribute to the global realization of iconic projects in residential, retail, hospitality, and naval sectors. In the 2023 fiscal year, Mestieri achieved revenues of 95.7 million euros, a growth of 37.3% compared to the previous year.
